Vendor Policy for National Meets

1. All attendees at the Meet must be registered members. Therefore, all vendors are members.
2. Cushman parts dealers listed on the CCOA web site will be prioritized. By providing Cushman parts and services they are key to our members in this hobby.
3. CCOA will market vendor space to the list of Cushman parts dealers on the CCOA web site via a special email from the President as soon as the meet location and indoor vendor area layout are finalized. Ideally this email will be sent just before the magazine is published with registration information.
4. CCOA will not restrict vendors to only selling Cushman related products and services. Providing members with the opportunity to sell products and services at the Nationals serves our membership well.
5. The Meet Host is responsible for providing a space, table number and layout diagram to the CCOA board prior to the start of Meet registrations. The Treasurer receives vendor registrations and informs Meet Host of the number of vendors and requested tables. Meet Host is responsible for informing the Treasurer when vendor space is fully allocated. Meet Host is responsible for coordination with vendors for set up and layout. The Treasurer will refund and/or not accept any further vendor registration. The Nationals locations often have ample space, but sometimes space is limited. It is important for someone to manage the registration and layout so that expectations are met.
6. Vendor registration should include a short description of the planned products and services to be offered so that we can review and head off any possible issue. For example, if a vendor plans to sell or post something vulgar, obscene, political or religious in nature. Registration should also include the business entity name, if there is one, associated with the vendor.
